





## 2. HOW DOES THE PROCESS WORK?

---

Accredited Centre status is achieved through a straightforward process. To show that you satisfy the criteria, you complete an initial application form followed by a face-to-face Zoom conversation. You will be asked to provide a sample of your training (course outlines, any assessments, sample of materials, etc.) and you may be asked for some other supporting documentation.

ITOL needs to satisfy itself that your training conforms to what we call 'learning logic' in other words - is it designed, and will it be delivered well enough to achieve its objectives and outcomes? - The sample will act as a 'model' of your training and on that basis **ALL OF YOUR COURSES WILL BE ACCREDITED**. Based on our initial consultations we trust you in ensuring that high quality standards are consistent and maintained throughout each program.

### 3. WHAT IS THE COST AND HOW LONG DOES IT TAKE?

---

The fee structure is simple:

- ❖ Annual Centre fee of £1300.00. This includes ALL courses being accredited and provides 3 Trainers with individual memberships.
- ❖ Individual student registration is £10.00 and includes Registration, Certification and Enrolment on to the ITOL International Validation register.
- ❖ We anticipate the process will be completed within approximately 20 working days.
